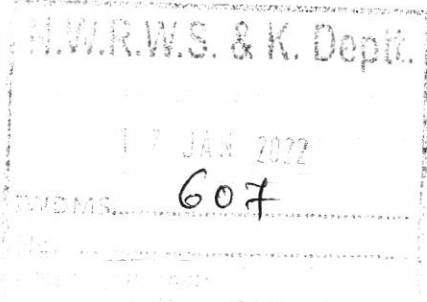

The Government of India, from time to time, has requested to take expeditious action for uploading the State Acts and their statutory subordinate legislations i.e. Statutory Notifications, Rules, Regulations, Orders, etc. pertaining to the various Departments of the State Government, on the India Code Web Portal. In this regard, I am directed to take necessary action as the matter is persistently observed by the GOI.

It is evident that though the departments have been frequently instructed for uploading the subordinate legislations, the progress of uploading the legislative documents is very slow and therefore, again I request you to kindly look into the matter personally and take necessary action for uploading the subordinate legislation documents and those who have not yet provided Hyper Link, are requested to provide Hyper Link to the India Code Portal on the respective Department's website of State Government as the matter is consistently reviewed by Hon'ble High Court of Delhi also and it needs to be completed in time-bound manner. The next date of hearing is on 28<sup>th</sup> January, 2022 before Hon'ble the High Court of Delhi.
